## Methodology

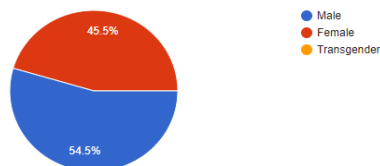

providing insights into participants' experiences and perceptions of the modules.

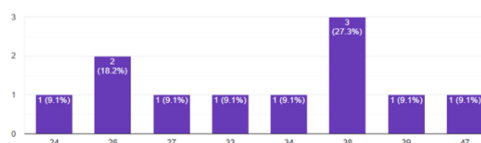
A questionnaire is employed to identify necessity of legal English among professionals.

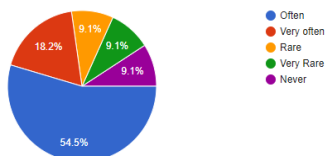
**Figure1: Gender responded to the questionnaire**

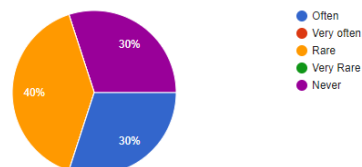
**Figure 3: Majority of them spending time to improve their communication skills.**

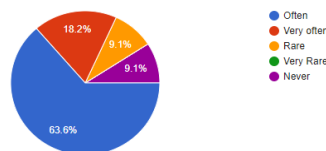
effectively. This involves consultations with legal practitioners, educators, and clients.

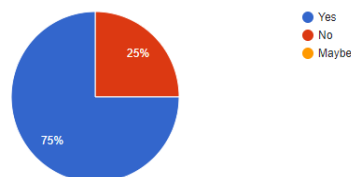
**Figure 4: It explains about the equally aware of the language development and the module**
